Sir,

With reference to the above cited subject, it is brought to the notice of the Board by Blue Cross of Guntur about the heinous and gruesome acts of animals sacrifices exposed with enclosed picture and videos, initiated in view of Gangamma jatara fest at Anantapuram Village, Lakkireddypalli Mandal, Kadapa District in Andhra Pradesh on the ill-fated 14.03.21. will be continued. A copy of the complaint is enclosed which is self-explanatory.

2. It is Violation of the Transport of Animals Rules, 1978 and (Amended in 2001 & 2009), Section 3 and 11(1) of The Prevention of Cruelty to Animals Act, 1960, And Section 428 & 429 of the Indian Penal Code, 1860. The Board had issued several advisories and circulars regarding the welfare of animals and the same is available in the website: [www.awbi.in](http://www.awbi.in)

3. The Hon'ble Supreme Court had directed to take action against the erring officials as per the Para 77 of the S.L.P.No.(C) 11686 of 2007, Animal Welfare Board of India Vs A.Nagaraja & Others and the department of Personnel and Training, Ministry of Personnel, Public Grievances and Pension had issued guidelines vide F.No.30/9/2006-Welfare dated 26.5.2006 to take action against such personnel violating the laws. The copies of the same is attached herewith for your information.

In view of the above, it is requested to direct the concerned authorities to investigate the matter and take necessary action against the erring officials as per the law. A detailed report be forwarded to the Board for information and further necessary action. .
