Sub: Alleged Complaint regarding the cruelty inflicted to stray dogs in Vikaspuri, Delhi - Reg.

Sir,

With reference to the above cited subject. It is brought to the notice of the Board by Ms. Neha Datta from Kg-1-560 DDA Pink Flats, Vikaspuri, New Delhi stating that she has been feeding and taking care of strays since almost six years. But now she is facing a lot of issues and harassment by the residents wherein she is looking after the dogs who were sick as they don't like or want her to continue to save lives of dogs over here who gets injured by their cars. The Guard's have been beating dogs from sticks in night on the command of Pradhan and residents. The dogs are not allowed to sit in that lane. A copy of the e-mail and letter is enclosed which is self-explanatory.

2. The cruelty against the animals is an offense under Section 3 and 11(1) of the Prevention of Cruelty to Animals Act, 1960, IPC 428 & 429 and violation of the directions of the Hon'ble Supreme Court of India.

3. The Hon'ble Supreme Court had directed to take action against the erring officials as per the Para 77 of the S.L.P.No. (C) 11686 of 2007, Animal Welfare Board of India Vs A.Nagaraja & Others and the department of Personnel and Training, Ministry of Personnel, Public Grievances and Pension had issued guidelines vide F.No.30/9/2006-Welfare dated 26.5.2006 to take action against such personnel violating the laws. The copies of the same is attached herewith for your information.

4. In view of the above, it is requested to investigate the above complaint and take appropriate action as per law against the offenders and forward your action taken report to the Board immediately to take further necessary action.
