Sir,

With reference to the above-cited subject, it is stated that the Animal Welfare Board of India (AWBI) has received an email dated 21.06.2021 from Blue cross of Guntur stated that the unethical, unconventional and unprofessional practices adopted by the Vijayawada Municipal Corporation Public Health Department authorities against the stray pigs on 21.06.21 at vicinity of the public in braod day light near Andhra Patrika Colony, Ajit Singh Nagar, Nunna Jurisdiction of Vijayawada Municipal Corporation limits, Krishna DistrictA copy of the complaint is enclosed herewith which is self-explanatory.

2. The Cruelty to animals is an offense under Section 3, Section 11(1) of the Prevention of Cruelty to Animals Act, 1960 and IPC.
3. The Hon'ble Supreme Court had directed to take action against the erring officials as per the Para 77 of the S.L.P.No.(C) 11686 of 2007, Animal Welfare Board of India Vs A.Nagaraja & Others and the department of Personnel and Training, Ministry of Personnel, Public Grievances and Pension had issued guidelines vide F.No.30/9/2006-Welfare dated 26.5.2006 to take action against such personnel violating the laws. The copies of the same is attached herewith for your information.
4. In view of the above, it is requested to conduct an enquiry and take appropriate action as per the provision of law and forward action taken report to the Board within 7 days to take further necessary action.
