**Sub: Request to direct all the officials to take appropriate action in implementation of the provisions of the Prevention of Cruelty to Animals (Slaughter House) Rules, 2001 and to immediate stop of pregnant cattle and calf slaughtering in Al Nasir S.S Masori Slaughter House, Dasna, Ghaziabad – Reg**

Sir,

With reference to the above cited subject, it is stated that the Board has received an email by Shri Abhishek from Gautam Baudh Nagar stating that illegal slaughtering of pregnant cattle and her calf in Al Nasir S.S Slaughter House, Dasna, Ghaziabad. A copy of the complaint is enclosed which is self-explanatory.


2. It is Violation of the Transport of Animals Rules, 1978 and (Amended in 2001 & 2009), Section 3 and 11(1) of The Prevention of Cruelty to Animals Act, 1960, FSSAI,2011 Norms, And Section 428 & 429 of the Indian Penal Code, 1860. The Board had issued several advisories and circulars regarding the welfare of animals and the same is available in the website: [www.awbi.in](http://www.awbi.in)

3. The Hon'ble Supreme Court had directed to take action against the erring officials as per the Para 77 of the S.L.P.No.(C) 11686 of 2007, Animal Welfare Board of India Vs A.Nagaraja & Others and the department of Personnel and Training, Ministry of Personnel, Public Grievances and Pension had issued guidelines vide F.No.30/9/2006-Welfare dated 26.5.2006 to take action against such personnel violating the laws. The copies of the same is attached herewith for your information.

4. In view of the above, it is requested to direct the concerned authorities to investigate the matter and take necessary action against the offenders as per the law. A detailed report be forwarded to the Board for information and further necessary action.
