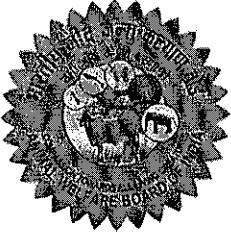

**Sub: Request to direct all the officials to take appropriate action regarding illegal transport of Animals in Bengaluru - Reg**

**Sir,**

With reference to the above cited subject, it is brought to the notice of the Board by Shri Tarun Agarwal stated that the K9 Puppies are being illegally transported from Bengaluru to Hydrabad by Jabbar Tours and Travelling Company which is against the provisions of the Transport of Animals Rules, 1978 and (Amended in 2001 & 2009) under Prevention of Cruelty to Animals Act, 1960 and Section 3 and 11(1) of the PCA, Act 1960. The Board had issued several advisories and circulars regarding the welfare of animals and the same is available in the website: [www.awbi.in](http://www.awbi.in) . A copy of the complaint is attached herewith.

The Hon'ble Supreme Court had directed to take action against the erring officials as per the Para 77 of the S.L.P.No.(C) 11686 of 2007, Animal Welfare Board of India Vs A.Nagaraja & Others and the department of Personnel and Training, Ministry of Personnel, Public Grievances and Pension had issued guidelines vide F.No.30/9/2006-Welfare dated 26.5.2006 to take action against such personnel violating the laws. The copies of the same is attached herewith for your information.

In view of the above, it is here by requested to issue a circular to all the authorities concerned to take strict action against the offenders for transporting the animals illegally and forward action taken report to the Board immediately.
