Sir,

With reference to the above cited subject, it is stated that the Board has received an email dated 23.02.21 from Ms. Shivani Bhalla stating that her father aged 66 yr old was bitten by a street dog. The street dog menace and dog bites cases has been severally increased in the area of New Multan Nagar, Paschim Vihar, New Delhi as well as there is constant fear of street dogs in the residents of the area. A copy of the complaint is enclosed here with which is self explanatory.

In view of the above, it is requested to ensure the proper sterilization the dogs in given area and to strictly implement Animal Birth Control Programmes as per the Animal Birth Control Rules,2001, for the control of the dog population. Further, it is requested that an inquiry on the above complaint may be initiated and an action taken report may be forwarded to the Board immediately to take further necessary action.
