Sub: Alleged complaint regarding brutal killing of 8 Stray dogs in Madurai – Reg

Ref.: E-mail dated 04.01.2021 received from Shri. P.Ramesh.


With reference to the above cited subject, it is stated that the Board has received an e-mail from Shri P.Ramesh stating that 8 stray dogs were brutally killed by Mr. Murugan. One year before he was killed 4 stray dogs and recently he mixed a poison with food to kill street dogs, as a result 4 stray dogs died after eating the poison food. A copy of the e-mail is attached which is self-explanatory.

Killing of animals is an offense under Section 11(1) of the Prevention of Cruelty to Animals Act, 1960, Animal Birth Control (Dogs) Rules, 2001 and Section 428 & 429 of Indian Penal Code, 1860.

The Hon'ble Supreme Court had directed to take action against the erring officials as per the Para 77 of the S.L.P.No.(C) 11686 of 2007, Animal Welfare Board of India Vs A.Nagaraja & Others and the department of Personnel and Training, Ministry of Personnel, Public Grievances and Pension had issued guidelines vide F.No.30/9/2006-Welfare dated 26.5.2006 to take action against such personnel violating the laws. The copies of the same is attached herewith for your information.

In view of the above, it is requested to conduct an enquiry into the matter and take necessary action as per law against the offenders and forward a copy of the action taken report to the Board at the earliest.
