Sub: Request to investigate the allegation against the Dr. Jaideep, Veterinarian for gross violation of PCA, Act, 1960 -reg.

Sir,

With reference to the above-cited subject, it is stated that the Board is in receipt of complaints regarding improper implementation of Animal Birth Control programme leading to fatal death and dislocation of stray dogs by Bhindi Rishi Pashu Kalyan run by Mr. Hariom. Dr. Jaideep Veterinarian and Ors (Raju, Amarjot) in D.S area, secondary school Rail Coach Factory, Kapurthala, has been continuously working with the blacklisted organisation Bhindi Rishi Pashu Kalyan, Madhya Pradesh (MP380/2012), whose recognition has also been suspended in violation of the Animal Birth Control (Dogs) Rules,2001 and SOP of the AWBI. The copy of the complaint is attached herewith, which is self-explanatory.

2. In regard to the above it is stated that the said Dr. Jaideep Kumar, Veterinarian has been carrying out the ABC programme in complete violation to Animal Birth Control (Dogs) Rules,2001 and the SOP set up by the Board. The ABC programmes conduct by him has resulted in death of several dogs over the year due to ill-treatment and no post-operation care being provided.

3. It is stated, that as per Animal Birth Control (Dogs) Rules, 2001 and direction of the Hon'ble Supreme Court, the local Authority/State Government is to conduct an ABC programme through an Animal Welfare Organization duly recognised with the Board with experience and training to carry out the program. The Board has also issued a letter to all the District for effective implementation of ABC program through its district administration dated 18.08.2020(Copy enclosed).

4. Therefore in view of the above, it is requested to investigate the allegation against Dr.Jaideep, Veterinarian and give us the action taken report within 15 day of the issuance of this letter.
