2. Having heard learned counsel for the rival parties we are satisfied, that the directions passed by this Court on 11.7.017 should be limited to Rules 22(b)(iii), 22(d)(ii) & (v) and 22(e)(i) & (iii) of the Prevention of Cruelty to Animals (Regulation of Livestock Markets) Rules, 2017. Ordered accordingly.

3. We are also satisfied, that the direction contained with reference to the Prevention of Cruelty to Animals (Care and Maintenance of Case Property Animals) Rules, 2017, deserves to be vacated. Ordered accordingly.
