### **EMPANELMENT OF HONORARY STATE / UT LEGAL ANIMAL WELFARE OFFICER**

The Animal Welfare Board of India (AWBI), established under an Act of Parliament, engaged in prevention of cruelty to animals and their welfare want to empanel the Honorary State Legal Animal Welfare Officer in every State / UT in the Country who should have the following requisites:

- Working on animal welfare;
- Work experience as an Advocate for minimum five years in his / her respective High Court;
- Age Minimum 30 years.

The Honorary State Legal Animal Welfare Officer will look after all the legal matters in their respective High Court including preparation and filing of various legal documents in the Court, following the required procedure and taking necessary action, suing and defending the case on behalf of the Board and for appearance before the various Hon'ble Courts including Hon'ble High Court in their respective state and UT. He / She will also provide legal advice to the Honorary District Animal Welfare Officers, Honorary State Animal Welfare Officer, Animal Welfare Organizations, Local administration and State Government.

## **Terms and Conditions for Honorary State Legal Animal Welfare Officer (HSLAWO)**

1. He / She will coordinate all the legal issues and the legal matters with the concerned Departments of the State Government.
2. He / She will coordinate with AWBI Honorary District Animal Welfare Officer and Honorary State Animal Welfare Officer.
3. He / She will look after and represent in all the legal matters in various Courts including District Courts and High Court.
4. He / She will attend specially designed training programme of AWBI on his own cost as and when intimated.
5. He / She will submit his / her Activity Report on quarterly basis to the AWBI.
6. He / She will not be allowed to misuse the AWBI name and shall also not indulge specially in any activity relating to cruelty to animals and against the State Government, Central Government and AWBI.
7. He / She will not demand / receive any money illegally from any person in performing of his / her duties on behalf of the Board.
